Act No. 348 was improperly numbered
as Act #348 in the Notary's Original
Index. Act reads Succession of
William H. Ireland, Inventory.

Act numbers on page two of Index were
mutilated, when the volume was received
by the Book Binding Project.

Acts 147, 197 & 198 are indexed in Notary's
Original Index, this was evidently a mistake.
The said Acts will be found in the Jan. -
July 25th 1832 volume.
