PETITION FOR ACTION OBJECTING TO CANDIDACY

NOW INTO COURT, through undersigned counsel, come Devon Diaz and Victor Robinson (hereinafter collectively referred to as "Plaintiffs"), persons of full age of majority residing and domiciled in the Parish of Orleans, State of Louisiana, who urge this Honorable Court to disqualify the candidacy of Fredrick "Freddy" Brooks for the following reasons, to wit:

I.

Plaintiffs herein, Devon Diaz and Victor Robinson, are registered and qualified voters in the Parish of Orleans. Plaintiffs are qualified electors for the Sheriff of the Parish of Orleans and have standing to bring this candidacy-objection action pursuant to Louisiana Revised Statute §18:491(A) and §18:1401(A).

II.

Defendant herein, Fredrick "Freddy" Brooks, is a person of the full age of majority domiciled in the Parish of Orleans, State of Louisiana.

III.

Also made Defendant herein is the Honorable Arthur A. Morrell, a person of the full age of majority domiciled in the Parish of Orleans, State of Louisiana. As required by Louisiana Revised Statute §18:1402(A)(2), Mr. Morrell is joined as a Defendant to this action in his capacity as the Clerk of Court for Criminal District Court for Orleans Parish, the Chief Election Officer for Orleans Parish, and, upon information and belief, the official before whom Mr. Brooks qualified for the candidacy and election at issue in this action.

IV.

This court has exclusive original jurisdiction over actions objecting to candidacy for elections within its district. See Louisiana Revised Statute §18:1403.

V.

Venue is proper in this Court as this action objecting to a candidate involves an office filled by an Orleans Parish election. See Louisiana Revised Statute § 18:1404.

VI.

This Petition is timely under Louisiana Revised Statute §18:1405(A).

VII.

This action challenges the candidacy of Mr. Brooks for the Sheriff of the Parish of Orleans and seeks to disqualify him from the primary election for that office, which election is scheduled to be held on October 14, 2017.

VIII.

On July 12, 2017, Defendant Fredrick "Freddy" Brooks filed a Notice of Candidacy seeking to qualify for the office of Sheriff for the Parish of Orleans in an election to be held on October 14, 2017. A copy of said Notice of Candidacy form is attached hereto as Exhibit "A".

IX.

As required by Louisiana law and, in particular, Louisiana Revised Statute §18:463(A)(2)(a)(iv), Mr. Brooks certified the following in the Notice of Candidacy: "*If I am a candidate for any office other than United States senator or representative in congress, that for each of the previous five tax years, I have filed my federal and state income tax returns, have filed for an extension of time for filing either my federal or state income tax return or both, or was not required to file either a federal or state income tax return or both.*"

X.

Upon information and belief, that certification appearing at paragraph 8 of Mr. Brooks' Notice of Candidacy is false. On July 18, 2017, a public records request was made to the Louisiana Department of Revenue (hereinafter referred to as the "LDR") for information regarding any income tax returns filed by Mr. Brooks for the tax years 2011, 2012, 2013, 2014, 2015 and 2016. In response to the public records request to the LDR, Vanessa C. LaFleur,

Custodian of Records for the LDR, responded to the request by letter stating that the LDR cannot confirm filing for the subject returns for the subject tax periods for Mr. Brooks. A copy of the LDR correspondence is attached hereto as Exhibit "B".

XI.

As provided in Louisiana Revised Statute §18:492(A)(7), a false certification under Louisiana Revised Statute §18:463(A)(2)(a)(iv) serves as a ground to object to a person's candidacy in a primary election. The sanction for such a false certification is disqualification from the primary election under Louisiana Revised Statute §18:494(A).

XII.

On these bases, therefore, Plaintiffs seek a Judgment from this Court disqualifying Mr. Brooks as a candidate in the October 14, 2017 primary election for Sheriff for the Parish of Orleans.

XIII.

Pursuant to Louisiana Revised Statute §18:1406(A), upon filing, a copy of this Petition is being posted at a "conspicuous place at the entrance" of the office of the Clerk of this Court.

XIV.

Pursuant to Louisiana Revised Statutes §18:1406(C) and §18:1409(A)(1), this action challenging the candidacy of Mr. Brooks must be tried summarily in open court without a jury. Under statute, the trial shall begin no later than 10:00 a.m. on the fourth day after suit is filed. The fourth day from the date of filing this Petition is Sunday, July 23, 2017. As such, the trial on this Petition shall begin no later than Friday, July 21, 2017, so as to comply with Louisiana Revised Statutes §18:1406(C) and §18:1409(A)(1).


XV.

By operation of law, in filing the Notice of Candidacy, Mr. Brooks appointed the Clerk of this Court, the Honorable Dale N. Atkins, as his agent for service of process in this action challenging his candidacy. See Louisiana Revised Statute §18:1407. Out of an abundance of caution, because there are criminal and civil district courts in the Parish of Orleans, Plaintiff also is serving the Honorable Arthur A. Morrell, Clerk of the Criminal District Court for the Parish of Orleans, as Mr. Brooks' agent for service of process. This Petition and its accompanying citation

are being served on Ms. Atkins and Mr. Morrell, in those capacities, as provided by Louisiana Revised Statute §18:1408(A). Further in accordance with that statute, the Plaintiff also is undertaking a diligent effort to effect personal service on Mr. Brooks at the domiciliary address shown on the Notice of Candidacy.

WHEREFORE, Plaintiffs, Devon Diaz and Victor Robinson, pray that this Petition be deemed good and sufficient, that the Defendants be cited to appear for the trial of this action to commence Friday, July 21, 2017, and that, after due proceedings are had, Judgment be rendered in their favor and disqualifying Fredrick "Freddy" Brooks as a candidate in the primary election for the Sheriff of the Parish of Orleans scheduled for October 14, 2017, along with all other general or equitable relief that this Court may deem just and proper.



IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that Plaintiffs', Devon Diaz and Victor Robinson, Petition for Action Objecting to Candidacy is hereby **GRANTED**.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that Defendant, Fredrick "Freddy" Brooks, has violated La. R.S. §18:463 (A)(2)(a)(iv) by falsely certifying on his Notice of Candidacy that he has filed his state income tax returns for the years of 2011, 2012, & 2013.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that the sanction for such a false certification is disqualification from the primary election under La. R.S. §18:464(A).

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that Fredrick "Freddy" Brooks' name be stricken from the ballot for the election for the Sheriff of the Parish of Orleans, set to take place October 14, 2017.
